#### FAMILY LAW DOCUMENT CHECKLIST

One of the most important documents family law clients usually are required to complete is the Form F8 Financial Statement, a prescribed form under Rule 5-1 of the Supreme Court Family Rules. It requires information on the client's income, expenses, assets, and liabilities and is frequently appended as schedules to family law agreements as evidence of full financial disclosure by both parties.

Section 84 of the Family Law Act of British Columbia defines **family property** as: All real property and personal property owned by either spouse as of the date of separation.

Section 85 of the Family Law Act defines **excluded property** as: Property acquired by either spouse before the relationship between the spouses began; this could include gifts or inheritances, a personal property settlement, or proceeds from an insurance policy. Any increase in the value of **excluded property** is considered from the date it is received to the date of separation to be family property.

If your separation involves the division of property or child or spousal support, you will need to gather documents for any of the following assets, debt expenses, or income that are relevant to you or your family:
